The obligation of Guarantor shall be primary, unconditional, continuous and unlimited. Guarantor expressly waives notice of acceptance, sales, or default. In the event of a default by Applicant, WALTHAM LUMBER shall be entitled to proceed directly to enforce its rights against Guarantor under this Guaranty, without exhausting any other remedies. Guarantor agrees to pay all fees, costs, and expenses, including reasonable attorney's fees, which WALTHAM LUMBER may incur in enforcing this Guaranty. This Guaranty shall be interpreted and governed by the laws of Massachusetts. This Guaranty shall be binding against the representatives, heirs, successors and assigns of Guarantor. If executed by more than one person, the obligations of this Guaranty shall be joint and several. The undersigned authorizes WALTHAM LUMBER to obtain a consumer credit report on the undersigned individuals through credit and consumer reporting agencies or other sources, in order to evaluate the creditworthiness of such individual in connection with the extension of business credit to Applicant.
